INVITATION



International Marketplace and Exhibition of Minerals and Jewellery is the most important part of Lwówek Achate Summer Festival (Crystal Days), which has taken place in Lwówek Śląski since 1998. The exhibition attracts a lot of guests. The stands of the marketplace are placed outdoor and each of them is covered and lit. Apart from selling minerals and jewellery, the administrators provide the opportunity to attend in the competition for the most interesting collection of minerals (with the independent set of regulations). There are also minerals connected workshops, lectures and slide shows.

The Marketplace rules

§ 1

Terms and Conditions for being granted a stall or place to set a canopy at Crystal Days XXV LLA:

- 1 - It is required that an application form is filled out in a legible manner (with capital letters), correctly (in all applicable sections) and sent over to the organizer's office before the deadline of 30 April 2024 (applications forms sent after that date will be accepted only on a reserve list).
- 2 - Exhibitor must also be provided by the organizer with a confirmation of being granted a stall or a place to set a canopy up either by post, email or over the phone (due to a limited number of places, both the order of sending submissions as well as the quality of the proposed mineral collections, fossils and jewellery craftsmanship products matter). By the handwritten signature the exhibitor must confirm they acknowledge and accept the conditions of participation in Crystal Days LLA.
- 3) - The payment of the amount determined by the organizer on basis of the application received from the exhibitor (account number and payment date indicated by the organizer with confirmation of given stand or tent space).

§ 2

Exhibitors who have been approved by the organizer to take part in Crystal Days LLA are provided with:

- 1 - exhibition stalls with roof covers and lighting with a display area of 2 square metres or a place to set a canopy (all stalls and places are tantamount, and it is solely the organizer's right to allocate them).
- 2 - electricity from electrical outlets 230V (on the condition of specifying such a requirement by filling in the area that says: „Additional remarks and requests for the organizers" on the APPLICATION FORM)
- 3 - the opportunity to present and sell throughout the three days of the event:

§ 3

1. Wooden exchange stands (prepared by the organizer) are located in the protected area.
2. The exchange tent stands (exhibitors' own tents) are located in the unprotected area.

§ 4

§ 5

Cars are allowed to temporarily stop within the area of the fair solely at the time planned for assembly and dismantling of the expositions. Leaving the car by an exhibitor in the mentioned area beyond those time limits will be considered violating the rules and regulations of Crystal Days LLA.

§ 6

The exhibitor's participation in competition exhibitions on the basis of separate regulations does not exempt the exhibitor from the fees applicable on the exchange.

§ 7

Fees payable for stalls at IMAITF LLA:

- 1 - for a granted permanent stall (a table with a roof cover and lighting of a display surface of 2 square metres):
550 PLN + VAT - display area for products or both minerals and products.
450 PLN + VAT - discounted fee - in case of displaying only unprocessed minerals, specimens for collectors and/or fossils.
400 PLN + VAT - members of Mineralogical Societies and Associations, who paid for their membership fees in full, and who only display unprocessed minerals, collectors' specimens and/or fossils.
(Stall displaying jewellery craftsmanship products or mixed products exposition - meaning products and minerals and/or fossils - is not allowed a discount).
- 2 - for granting a place to set up a tent:
220 zł + VAT for 1 running metre - for minerals, fossils, products, alternatively for both: minerals and products.

§ 8

During Crystal Days LLA all exhibitors are obliged to:

- 1 - keep their stalls at an appropriate level of aesthetic standards;
- 2 - put in a visible place the descriptions of the presented specimens including localities and names of minerals;
- 3 - put in a visible place the prices of the specimens for sale;
- 4 - clearly label all "synthetic minerals";
- 5 - have an entry card issued by the organizer of the event, it is handed over to the exhibitor along with the decision to grant a stall (a fee of 50 zł will be charged to issue a replacement entry card in case of its loss);
- 6 - make sure that the ID badge received from the organizers is kept visible at all times.

§ 9

Only mineral specimens (natural and synthetic), ornamental stones, semi-precious stones, gemstones, fossils, amber, etc., as well as products made out of the aforementioned, may be displayed on the stalls of Crystal Days LLA.

Any attempts to exhibit artwork/products not specified on the exhibitor's application will entail losing the stall and being removed from the list of the exhibitors of Crystal Days LLA.

§ 10

All exhibitors are expected to adhere to all rules and regulations stated in § 3 of the fair's schedule. Causing a delay to open a stall, move-out or dismantling the granted stall before the fixed closing date without a clear justification may result in a loss of the granted place and being put on a reserve list.

§ 11

- 1 - The exhibitor is obliged to obey the exchange schedule set out in § 5
- 2 - Delaying opening of the stand, as well as leaving the allocated stand before the closing of the exchange without justification, may result in the loss of a place and transfer to the reserve list.

§ 12

An exhibitor who has received a confirmation of participation in MGMIWJ LLA and has paid for the stands, but due to fortuitous reasons cannot participate in it, is obliged to immediately notify the organizer of the resignation from participation.

In case of resignation from the stand within 7 (seven) or more days before the start of the LLA event, the organizer will refund to the Exhibitor 100% of the stand fee previously paid by the Exhibitor. In the event of resignation from the stand less than 7 (seven) days before the start date of the LLA event, the organizer does not refund the stand fee paid earlier by the Exhibitor to the Exhibitor.
