**INVITATION**

International Marketplace and Exhibition of Minerals and Jewellery is the most important part of Lwówek Achate Summer Festival (Crystal Days), which has taken place in Lwówek Śląski since 1998. The exhibition attracts a lot of guests. The stands of the marketplace are placed outdoor and each of them is covered and lit. Apart from selling minerals and jewellery, the administrators provide the opportunity to attend in the competition for the most interesting collection of minerals (with the independent set of regulations). There are also minerals connected workshops, lectures and slide shows.

The Marketplace rules

§ 1

Terms and Conditions for being granted a stall or place to set a canopy at Crystal Days XXVI LLA:

- 1) sending to the LLA organizational office a legibly (in capital letters) and correctly (in all fields) completed application form by the deadline of April 15, 2025. Application forms sent after the deadline will be accepted on the reserve list;
- 2) receiving an e-mail from the organizer confirming the allocation of a stand or a tent space;
- 3) paying the amount determined by the organizer based on the application received from the exhibitor (account number and payment deadline indicated by the organizer in the sent confirmation of receipt of the stand or a tent space);
- 4) acceptance by the exhibitor of the MGMIWJ LLA regulations confirmed by a handwritten signature.

§ 2

- 1) Due to the limited number of places, the order of submitting applications and the quality of the proposed collections of minerals, fossils and jewellery for display will be the deciding factor, subject to §2 point 2;
- 2) Exhibitors who had stands last year (2024) retain the right of priority to the same stands in the current year (2025) provided that the application form is sent by the deadline specified in the regulations and the fee for the allocated stands is paid in the amount and by the deadline specified in the confirmation received from the organiser.
- 3) Without the consent of the Organiser, the exhibitor may not give the stand to a third party for use or make it available.
- 4) Exhibiting a stand for a period shorter than 24 hours is treated as exhibiting a stand for one day.
- 5) In the case of exhibiting a stand for a period shorter than 3 days within the meaning of point 4, a proportional rate shall apply.
- 6) Application forms submitted after the deadline (April 15, 2025) will be placed on a reserve list and will be considered last.

§ 3

For exhibitors qualified to participate in MGMIWJ LLA, the organizer provides:

- 1) roofed and lit exhibition stands with an area of 2 m2 or places for a tent (all stands and places are equal and the organizer alone has the right to designate them),
- 2) possibility of using electricity 230V socket (provided that the exhibitor indicates such a need in the application form in the "comments and requests to the organizer" section),
- 3) possibility of presentation and sale over three days:

12.07 (Saturday) 10:00 - 20:00  
13.07 (Sunday) 10:00 - 18:00

§ 4

- 1. Wooden market stands (prepared by the organizer) are located in a protected zone.
- 2. Tented market stands (exhibitors' own tents) are located in an unprotected zone.

§ 5

Exhibition assembly, presentation and dismantling schedule:

- 1. Exhibition assembly (protected and unprotected zone):  
11.07. (Friday) from 9:00 to 14:00
- 2. Exhibition dismantling (protected zone):  
13.07. (Sunday) from 17:00 to 19:00
- 3. Exhibition dismantling (unprotected zone):  
11.07. (Friday) after 20:00

- 12.07. (Saturday) after 20:00
- 13.07. (Sunday) after 18:00
- 4. Opening of the exchange for exhibitors (protected zone):  
11.07. (Friday) from 9:00  
12.07. (Saturday) from 9:00  
13.07. (Sunday) from 9:00
- 5. Exhibition presentation time for visitors (protected and unprotected zone):  
11.07. (Friday) from 15:00 to 20:00  
12.07. (Saturday) from 10:00 to 20:00  
13.07. (Sunday) from 10:00 to 18:00

§ 6

- 1. Parking of cars on the fairgrounds is only possible during the time provided for the preparation and dismantling of the exhibition.
- 2. Leaving a car on the fairgrounds by the exhibitor outside the established hours is tantamount to a violation of the fair regulations.

§ 7

- The applicable fees for IMaITF LLA stands (include VAT):
- 1. For a roofed and lit table with an area of 2m2 in a protected zone:  
PLN 800 - for products or an area divided between minerals and products,  
PLN 680 - reduced fee - in the case of exhibiting only unprocessed minerals, collectors' items and/or fossils,  
PLN 560 - members of mineralogical associations and societies with paid contributions, exhibiting only unprocessed minerals, collectors' items and/or fossils,
  - 2. For a place for a tent in a non-protected zone:  
PLN 340 per 1 m - for minerals, fossils, products or an area divided between minerals and products.

§ 8

- An exhibitor participating in the IMaITF LLA is obliged to:
- 1) maintain the stand at an appropriate aesthetic level;
  - 2) place descriptions of the exhibits presented in a visible place including the locations and names of minerals;
  - 3) place prices of exhibits intended for sale in a visible place;
  - 4) clearly mark "synthetic minerals";
  - 5) have an entry card issued by the event organizer and given to the exhibitor together with the decision on the allocation of the stand (a fee of PLN 50 is charged for issuing a duplicate entry card in the event of its loss);
  - 6) display in a visible place the ID received from the organizers.

§ 9

- 1. Only minerals (natural and synthetic), ornamental, semi-precious and precious stones, fossils, amber, etc. and products made from the above may be presented at Crystal Days LLA stands.
- 2. Exhibiting at a stand any other assortment than the above will result in the loss of the stand and deletion from the list of Crystal Days LLA exhibitors.

§ 10

All exhibitors are expected to adhere to all rules and regulations stated in § 3 of the fair's schedule. Causing a delay to open a stall, move-out or dismantling the granted stall before the fixed closing date without a clear justification may result in a loss of the granted place and being put on a reserve list.

§ 11

- 1. The exhibitor is obliged to adhere to the market schedule set out in § 5.
- 2. Delaying the opening of the stand or leaving the allocated stand before the market closes without justification may result in the loss of space and transfer to the reserve list.

§ 12

An exhibitor who has received confirmation of participation in the MGMIWJ LLA and has paid for the stands but cannot participate due to unforeseen circumstances is obliged to immediately notify the organizer of the withdrawal from participation.

In the event of notification of withdrawal from the stand within 7 (seven) or more days before the start of the LLA event, the organizer will refund to the exhibitor 100% of the stand fee previously paid by the exhibitor. In the event of notification of withdrawal from the stand less than 7 (seven) days before the start of the LLA event, the organizer will not refund to the exhibitor the stand fee previously paid by the exhibitor.
